South Street Entrance – MM confirmed that the weed mat gravelling and additional planting at South Street entrance has now been completed. MM passed on her thanks to AL and the Grounds Team. All who had seen it agreed it was a huge improvement.

Pizza Boxes – TY confirmed that he had spoken to Biddulph pizzas, who confirmed that they have not used boxes since May 2023, only for people who are taking their pizzas away from the cricket club. TY requested that if we encounter similar issues next summer, maybe we could get some photos of the pizza boxes so that we can identify which establishment they have come from.

CCTV – MM confirmed that the minutes from the past
Pubwatch meetings had been provided to AM, however, there
was no mention in the minutes of dates cctv would be
installed.

Bath Grounds Roadway – AL confirmed that ATC have completed some temporary repairs to the roadway at Prior Park Road end of the Bath Grounds, to fill in the potholes and that 3 tonne of stone was used to carry out these repairs. A brief discussion took place on options for more long-term solutions for the roadway surface.

Fruit Trees – MM reported that the fruit trees have now been planted and requested that some kind of protective cage could be put around them. AL asked if some plaques could be displayed, advising people what the trees are. MM confirmed that these could be purchased and attached to the protective cages.
